Approved applications for Daum Transport (Bradford County); Good Samaritan Limousine Service II Inc. (**York, Adams and Lancaster counties**); Comfort Ride Transit Inc. (**Philadelphia County**); Berks Area Regional Transportation Authority (**Berks County**); **The Eric Ryan Corp.**; **PPL Electric Utilities Corp.**; **Finger Lakes Technologies Group Inc.**; **ConocoPhillips Pipe Line Co.**; **MCENERGY Inc.**; and **Service Electric Telephone LLC**.

Approved applications as amended for Joseph S. King (**Chester County**); and Janet Esh (**Lancaster, Lebanon, Perry, York, Dauphin and Berks counties**).

Approved applications for discontinuance or abandonment of service for Friendly Taxi Cab of Lancaster (**Lancaster County**); Keener Transportation (**York County**); L&L Transportation Co. Inc. (**Cumberland County**); Jeffrey & Anita Houseknecht (**Lycoming and Sullivan counties**); Promobile Transportation Inc. (**Philadelphia County**); Catawese Coach Co. (**Philadelphia County**); and Pennsylvania Transit Co. LLC (**Philadelphia County**).

Dismissed the application of Vital Spirit (**Northampton County**).

Made public the gas cost rate report for **Chartiers Natural Gas Co.**

Approved the generation supply adjustment for **PECO Energy Co. – Electric** to become effective May 1, 2012; and the purchased water adjustment charge for **Newtown Artesian Water Co.**

Adopted the proposed opinions and orders denying the petition for reinstatement of Integrity Limousine (**Montgomery, Chester,**

Bucks, Delaware and Philadelphia counties); granting the exceptions, in part, denying, in part, and modifying the initial decision regarding the application of **Pentex Pipeline Co.**; granting the joint petition for approval of an interconnection agreement and amendment of **Zito Media Voice LLC** and **Verizon Pennsylvania Inc.**; and granting the joint petition for approval of an interconnection agreement and amendment of **Zito Media Voice LLC** and **Verizon North Inc.**

Adopted the proposed orders approving the letter of notification of **PPL Electric Utilities Corp.** for approval of construction of the West Trexlertown No. 1 and No. 2 138/69-kV tap line in Upper Macungie Township, **Lehigh County**, and the petition for approval of a finding that a building to shelter control equipment at the West Trexlertown 69-12-kV substation to be construction in Upper Macungie Township, **Lehigh County**, is reasonably necessary for the convenience or welfare of the public, and therefore exempt from any local zoning ordinance; approving the petition of request of **Duquesne Light Co.** to implement Time of Use-1 and Time of Use-2 pilot programs for the timeframe of June 2012 through September 2012, and approving Supplement No. 57, Electric Tariff Pa. P.U.C. No. 24; granting in its entirety the petition requesting approval of the termination of the power purchase agreement with Northampton Generating Co., L.P., filed by **Metropolitan Edison Co.**; granting a petition by **Columbia Gas of Pennsylvania** to contribute proceeds stemming from a settlement with **Columbia Gulf Transmission Co.** to programs that help low-income customers pay their bills and to provide refunds for some small business customers, approving the letter of notification of **PPL Electric Utilities Corp.** for approval of the replacement of all conductors, the shield wire and one wooden-structure on 12.8 miles of

existing Susquehanna-Harwood No. 1 and No. 2 230 kV transmission line in Conyngham, Hollenback, Sugarload and Hazle townships, Luzerne County, and approving the letter of notification of **PPL Electric Utilities Corp.** for approval of the siting and construction of the West Shore-Harrisburg No. 1 and No. 2 138/69 kV transmission line to address reliability concerns in Lower Allen Township, Cumberland County.

Instituted an investigation into the proposed rate increase request of **Peoples Natural Gas Co.**

Dismissed the petition of **Neustar Inc. for relief for the 814 area code**, rescinded the implementation of the geographic split as the form of area code relief, and denied as moot the petitions for reconsideration.

Granted, in part, and denied, in part, the petition requesting that a two-year trial waiver that permitted **Verizon Access Transmission Services LLC** to provide the rates and terms for basic dial-tone services offered to enterprise and large business customers on its Internet website in lieu of filing a formal tariff filing be made permanent.

Adopted the secretarial letter temporarily delaying action on the final implementation Order of **Act 13 of 2012**, due to an ambiguity in an injunction from the state's Commonwealth Court.

Approved the 911 system renewal plan for Clarion County.

Adopted the initial decisions of the administrative law judge (ALJ) denying the complaint in the case of Tracy Wood vs. **PECO Energy Co. – Electric**; and dismissing the complaint in the case of Wallace and Janet Martin vs. **Duquesne Light Co.**

Adopted the ALJ's recommended decision approving the settlement regarding the application filed by the **City of Philadelphia** for approval to reconstruct the bridge carrying South Street.

Adopted the motion of Vice Chairman Coleman in the case of Sharon Bracken vs. **Champion Energy.**

Adopted the motion of Commissioner Cawley in the case of In Home Oxygen and Medical Equipment vs. **Verizon Pennsylvania Inc.**
