The United Telephone Company of Pennsylvania LLC d/b/a CenturyLink (f/d/b/a Embarq Pennsylvania) propounded a Set II Interrogatories and Request for production of Documents (“CTL-Qwest Set II”). An error was found in questions CTL-Qwest 2-13 and 2-14. The phrase “Sprint” is in error and should be replaced by “Qwest” as noted below:

Provide all documents, studies, and analyses.
- CTL-Qwest 2-14** From January 1, 2003 through present, identify each RLEC and CenturyLink intrastate switched access rate reduction received by ~~Sprint~~ Qwest and provide the specific, corresponding non-rate actions ~~Sprint~~ Qwest undertook as a result. Provide all documents, studies, and analyses.

No other changes to CTL-Qwest Set II are necessary. The due date for responding to these revised questions is extended by one (1) day due to the typographical error.


