

C.S. § 2809(c), enclosed please find an original and one copy of a general purpose rider extending the period of the bond covering Hess Corporation's ("Hess") electric supplier license (Bond No. 929123875) to cover the period from February 15, 2011 through February 14, 2012. In addition, and as will be confirmed in Hess' upcoming annual electric supplier report due on April 30, 2011, Hess is increasing the security level of its bond to \$9,265,642 to reflect an amount equal to 10% of Hess' gross intrastate electric receipts in the Commonwealth of Pennsylvania for calendar year 2010.






