In an Order dated February 15, 2012 you granted the Motion of Interstate Gas Supply, Dominion Retail, Hess and Direct Energy (the "Natural Gas Supplier Parties" or "NGSs"), filed in the above-captioned matter, to hold this matter in abeyance pending resolution of the ongoing Purchase of Receivables ("POR") Collaborative. By letter dated April 18, 2012, the NGSs reported on the status of the collaborative and requested additional time to continue discussions. By Order issued May 1, 2012, you granted that request and requested an update with thirty days.

The purpose of this letter is to request a further extension of time before a further status update us required. The NGSs believe that vacations and holidays may slow the process during this time of year. Progress has been made, however, the Parties require additional time to determine their final positions, but the NGSs believe further progress has been made on resolving significant issues with certain parties.

The Parties to the proceeding before you, Philadelphia Gas Works ("PGW") and the POR Collaborative Participants have continued to exchange new proposals, and proposals are pending for evaluation by the members of the collaborative process. Further responses from collaborative participants are needed before the discussions can be concluded.

Therefore, the NGS Parties respectfully request that Your Honor allow the Parties to continue these discussions and provide another procedural update to you in not less than thirty (30) days of this request. No Party to the case before you objects to this request.


