Dear Judge Pell:

On October 9, 2012, you issued an Order in the above-captioned matter granting the request of the Natural Gas Supplier Parties (“NGS Parties”) for additional time to resolve this matter and requiring that they provide you with a procedural update. Your Order granted an additional ninety (90) days and required a procedural update on or before December 20, 2012.


The purpose of this letter is to comply with the procedural update requirement and also to request an additional ninety (90) days within which to resolve this matter. The Parties have been engaged in negotiations on a continuous basis and the additional time will be spent in an effort to conclude those discussions, and hopefully this matter, in a manner that will not require litigation. However, there is a need to develop additional data and additional understanding with regard to certain components of the various positions, before this matter can be successfully and finally concluded. The purpose of the additional time, in part at least, is to develop that additional information and understanding.

The NGS Parties have discussed this matter with PGW and the Office of Consumer Advocate, and neither object to allowing additional time to continue the discussions. The NGS Parties further believe that no other party to this proceeding will object to the grant of additional time for purposes of concluding this matter.
