**BY THE COMMISSION:**

On March 14, 1997, CNG Retail Services Corporation ("CNGRSC") filed a License Application to become an electric generation supplier. This filing is made pursuant to the provisions of Section 2809 of the Public Utility Code, 66 Pa. C.S. § 2809.

Our Final Order entered on February 13, 1997 at Docket No. M-00960890 F.0004, provides, in Appendix B, that a license application is to be processed within forty five days, unless the Commission extends the review period.
