Re: Electric Generation Supplier Services License A-110005

Dear Mr. Kooper:

On May 8, 1997, the Commission issued an interim license at Docket No. A-110005, authorizing Eastern Power Distribution, Inc. the right to begin to offer, render, furnish, or supply electric generation supplier services to commercial and industrial customers within the Commonwealth of Pennsylvania. By Secretarial Letter on August 18, 1998, the Commission approved the transfer of the license to Statoil Energy Services, Inc. By Secretarial Letter, on June 1, 2000, the Commission approved a name change on the license to Hess Energy, Inc.

On April 15, 2002, Amerada Hess Corporation ("AHC") and Hess Energy, Inc. filed a Joint Application to approve the transfer of the license from Hess Energy, Inc. to AHC. The transfer was approved by Commission Order, entered July 19, 2002.

On May 10, 2006, AHC filed a request that the Commission change the name on its license to provide electric generation supplier services from AHC to Hess Corporation.

Hess Corporation has provided proper documentation as required by this Commission.

Therefore, the Commission approves, by this Secretarial Letter, the change of AHC's name on its license for the provision of electric generation supplier services to commercial and industrial customers, within the Commonwealth of Pennsylvania, at Docket No. A-110005, to Hess Corporation.
