**Re: Petition for Issuance of Permanent License as Electric Generation Supplier;
CNG Retail Services Corporation, A-110008**

Dear Mr. McNulty,

CNG Retail Services Corporation ("CNGRSC") hereby petitions the Pennsylvania Public Utility Commission (the "Commission") for issuance to CNGRSC of a Permanent License as an Electric Generation Supplier. CNGRSC (which does business in Pennsylvania under the fictitious name of "Peoples Plus") received its Interim License at Docket No. A-110008, dated June 27, 1998. CNGRSC requests continued authority to offer, render, furnish or supply electric generation supplier services to all classes of customers throughout the Commonwealth of Pennsylvania.

In support of this Petition for a Permanent License, CNGRSC submits the following:

1. CNGRSC remains a Delaware corporation in good standing and authorized to conduct business in the Commonwealth of Pennsylvania.

2. CNGRSC has participated as an electric generation supplier in the electric retail access pilot programs of Duquesne Light, GPU and Allegheny Power since November 1997. CNGRSC is also participating in the retail electric choice program on the Duquesne Light system with service commencing in January 1999.

3. CNGRSC has coordinated with Commission Staff on CNGRSC's residential customer electric disclosure statement for use in Duquesne Light's program.

4. CNGRSC is currently bonded pursuant to Commission requirements in the amount of \$250,000. CNGRSC's bond states that the Commission is the beneficiary under the bond.


CNGRSC will take action to renew its bond without interruption upon expiration of the current bond term.
