At the Public Meeting on September 15, 1999, the Commission approved the Application of Commonwealth Energy Corporation d/b/a Advantage Energy, Inc., for Approval to Offer, Render, Furnish or Supply Electric Generation Services as a Broker and/or Marketer of Electricity and Related Services in the Commonwealth of Pennsylvania. 




