

Enclosed for filing is the Revised Smart Meter Deployment Plan of West Penn Power Company ("Company") in both a red-lined and clean format. This plan is being filed pursuant to the Commission's March 6, 2014 Opinion and Order ("March 6 Order") in the above referenced docket. 
