Dear Secretary Chiavetta:

Pursuant to the Commission's *Interim Guidelines Regarding Notification by an Electric Generation Supplier of Operational Changes Affecting Customer Service and Contracts*, adopted on August 13, 1998 in Docket No. M-00960890F.0013, the purpose of this joint letter is to advise the Pennsylvania Public Utility Commission ("PUC" or "Commission") that Independence Energy Group LLC ("Independence Energy") and [REDACTED], have entered into an Asset Purchase Agreement for the acquisition by [REDACTED] of certain residential retail electric supply customer accounts of Independence Energy in the Commonwealth of Pennsylvania. Specifically, Independence Energy will assign to [REDACTED] approximately [REDACTED] for the provision of electric generation services. Independence Energy's license number is A-2011-226337; [REDACTED] license number is [REDACTED].

As 30-day notice is being sent to the impacted customers to inform them of the contract transfer. This notice includes the following information:
