Dear Secretary Chiavetta:

Peerless Network of Pennsylvania, LLC (Peerless Network) hereby submits written notice of compliance with the Federal Communications Commission's Report and Order reforming the intercarrier compensation regime (26 FCC Rcd 17663 (Rel. 11/18/11)) and the Public Utility Commission's Order dated April 23, 2014. Peerless Network's intrastate terminating end office access rate (which is \$0.002406 per minute) is already in compliance with the FCC's and Public Utility Commission's orders because it: (1) is lower than the Company's corresponding interstate rate, and (2) is lower than the corresponding rate recently filed by the underlying incumbent local exchange carrier Verizon (see, Verizon North and Verizon Pennsylvania tariff filings dated 5/19/14, proposing composite termination end office charges of between \$0.003162 and \$0.003099). As a result, Peerless Network does not need to modify its existing intrastate switched access rates in order to comply with the cap on CLEC access rates that will take effect on July 1, 2014.




