Effective immediately, PG&E Energy Services Corporation ("PG&E ES") hereby relinquishes its Electric Generation Supplier License, dated January 1, 1999. PG&E ES does not currently serve any electricity customers in Pennsylvania and is not engaged in any electricity marketing activities in the state. In connection with the relinquishment of the License, PG&E ES will take steps to cancel the \$250,000 surety bond required as a condition of licensure. PG&E ES will also take all appropriate steps to notify the utility distribution companies with which PG&E ES has supplier agreements of the relinquishment of the License.


