

BY THE COMMISSION:


Before the Commission for consideration and disposition is a Petition for Reconsideration (Petition), filed jointly by Buffalo Valley Telephone Company, Conestoga Telephone and Telegraph Company and Denver & Ephrata Telephone & Telegraph Company (collectively D&E Companies), on July 26, 2007, seeking

reconsideration on certain issues directed by our Opinion and Order entered July 11, 2007, relative to the above-captioned proceedings.

Pursuant to Rule 1701 of the Pennsylvania Rules of Appellate Procedure, Pa. R.A.P. Rule 1701, the Commission must act to grant a petition for reconsideration within thirty days of the date of entry of the order for which reconsideration is sought, or otherwise lose jurisdiction to do so if a petition for review is timely filed. The thirty-day period within which the Commission must act upon this Petition for Reconsideration in order to preserve jurisdiction, is August 10, 2007. Accordingly, we shall grant reconsideration, within the meaning of Pa. R.A.P. Rule 1701(b) (3), pending review of, and consideration on, the merits of the Petition; **THEREFORE,**

IT IS ORDERED: That the Petition for Reconsideration filed on July 26, 2007, by Buffalo Valley Telephone Company, Conestoga Telephone and Telegraph Company and Denver & Ephrata Telephone & Telegraph Company, is hereby granted, pending further review of and consideration on, the merits.
