
The Pennsylvania Public Utility Commission's Implementation Order at *Electronic Access to Pre-Served Testimony*, Docket No. M-2012-2331973 (Order entered January 10, 2013) requires that parties, within thirty days after the final evidentiary hearing in an adjudicatory proceeding, to either e-File with or provide to the Secretary's Bureau a CD containing all testimony furnished to the court reporter during that proceeding.


