Enclosed for filing with the Pennsylvania Public Utility Commission ("Commission") on behalf of UGI Utilities, Inc. – Electric Division ("UGI Electric" or the "Company") is its Compliance Phase II Energy Efficiency and Conservation Plan ("Compliance Phase II EE&C Plan"). To assist the Commission and the parties in reviewing this filing, the Company is submitting clean and redline versions of its Compliance Phase II EE&C Plan. A CD containing copies of the above-documents is also enclosed.

The Compliance Phase II EE&C Plan makes the necessary changes to the EE&C Plan in accordance with the Settlement approved by the Commission in its Order entered June 9, 2016. Further, the Company has made two additional edits: (1) UGI Electric changed the Conservation Service Provider for the Appliance Recycling Program from JACO to Recleim, because JACO has gone into receivership and is longer able to provide the services; and (2) UGI Electric removed footnotes indicating that the EnergyStar rating for natural gas clothes dryer is not available yet, because that rating is now available.
