

Dear Secretary Chiavetta:

On August 29, 2016, the Commission issued a Secretarial Letter tentatively directing Philadelphia Gas Works (“PGW”) to extend the Low-Income Usage Reduction Program (“LIURP”) component of its Demand-Side Management (“DSM”) plan until a compliance plan is filed in this docket. The Commission invited interested parties to file comments to this tentative directive by August 30, 2016.

In response to the Secretarial Letter and consistent with the Tentative Order and PGW’s letter dated August 25, 2016, PGW’s LIURP program will continue with no changes in the level of LIURP services pending a final order from the Commission approving LIURP (including LIME) and establishing the LIURP budget (including LIME) for Fiscal Year 2017 (and thereafter). To the extent the Commission issues a final order prior to September 30, 2016, PGW will be able to accommodate changes in the required spending based on the final approved budget. If, however, no final order has been issued by that point in time, then PGW expects that it would need to file at some point for additional input from the Commission regarding the on-going LIURP spending while the proceeding remains open.
