

Dear Secretary McNulty:

On July 14, 2005, ALJ Susan Colwell released the Order Suspending Procedural Schedule (“Order”) in the above-referenced case. In relevant part, the first paragraph of the Order states that United Telephone Company of Pennsylvania *d/b/a* Sprint (hereinafter “Sprint”) is opposed a stay of the proceeding, as recently requested by certain parties through interlocutory review.

As articulated during oral argument on the wireless carriers’ jurisdictional motion, Sprint has maintained that moderate and reasonable revenue neutral rate balancing can continue notwithstanding the FCC’s unified intercarrier proceeding. Sprint has not taken a position – and has not filed briefs – either in support of or in opposition to the interlocutory request and procedural stay sought by certain parties.


