Dear Secretary Chiavetta:

Pursuant to the Commission's *Interim Guidelines Regarding Notification by an Electric Generation Supplier of Operational Changes Affecting Customer Service and Contracts*, adopted on August 13, 1998 in Docket No. M-00960890F.0013, the purpose of this joint letter is to advise the Pennsylvania Public Utility Commission ("PUC" or "Commission") that Entrust Energy East, Inc. ("Entrust") and NRG Energy, Inc. ("NRG") have entered into an asset purchase agreement (the "Agreement") for the acquisition by NRG's retail subsidiary, Reliant Energy Northeast LLC d/b/a NRG Home ("NRG Home") of certain **[BEGIN CONFIDENTIAL]** **[END CONFIDENTIAL]** customer accounts of Entrust in the Commonwealth of Pennsylvania. Specifically, pursuant to the Agreement Entrust will assign to NRG Home approximately **[BEGIN CONFIDENTIAL]** **[END CONFIDENTIAL]** contracts for the provision of electric generation services to Pennsylvania retail customers. Entrust's license number is A-2012-2335819; NRG Home's license number is A-2010-2192350.

As required by the *Interim Guidelines*, a 30-day notice is being sent to the impacted customers to inform them of the contract transfer. This notice includes the following information:

- The transfer of service from Entrust to NRG Home will be initiated after the expiration of the 30 day notice period and that the effective date of the transfer is expected to occur as of the meter read date after **[BEGIN CONFIDENTIAL]** **[END CONFIDENTIAL]**.
- NRG Home's mailing address is P.O. Box 38815, Philadelphia, PA 19104-9728.
- The telephone number for NRG Home's customer service representatives is 1-855-500-8703.
- An explanation of the reason for the contract assignment as the transfer of certain assets from Entrust to NRG Home.
- Additional information about the transition from Entrust to NRG Home.

NRG Home and Entrust request that the Commission grant this notification confidential and proprietary treatment. The data provided herein is commercially

sensitive information that NRG Home and Entrust do not make public in any of our corporate reporting.




