Constellation Energy Power Choice, LLC ("CEPC") will assign some of their Pennsylvania retail electric customers to Constellation NewEnergy, Inc. ("CNE") in June 2017.

We have discussed with the Office of Competitive Markets Oversight ("OCMO") that the nature of this intracompany transaction is the equivalent of a minor name change and a license change. As such, sending the usual full-notice is not desirable because it may only confuse the customers. We have been advised that an abbreviated notice providing the new name and license number is appropriate and we will be sending this to our affected customers. A copy of the abbreviated notice is enclosed.

OCMO directed us to the EDCs and have them suppress the enrollment confirmation letters. We understand that this is generally standard practice in any assignment process.


