REQUEST TO RENEW REDUCED BONDING LEVEL

Dear Mr. Gill,

I am writing to renew the reduction in the level of security The Energy Cooperative Association of Pennsylvania (ECAP) is required to provide in order to operate as an electric generation supplier in Pennsylvania. ECAP currently provides a level of security equivalent to 5% of the previous years reported gross receipts or \$250,000, whichever amount is greater. I have included the following information:

1. \$350 payment
2. A signed certificate of service
3. A gross receipts summary for the most recent four quarters
4. A tax status letter of good standing

The Energy Co-op respectfully requests confidentiality for the gross receipts data included in the report. These figures represent sensitive operational information for The Energy Co-op. Such information, if it were to become publicly available, could harm the competitive and commercial operations of The Energy Co-op by providing competitors with access to The Energy Co-op's recent operating information providing direct insight into market position, size, and other closely held proprietary business information.


