
On June 15, 2017, UGI Penn Natural Gas, Inc. (“UGI PNG” or the “Company”) was served with a formal complaint by Robert L. Bassler, Jr. in the above-captioned base rate proceeding. Later that afternoon, the Administrative Law Judge assigned to this proceeding, the Honorable Mary D. Long, issued a letter to Mr. Bassler informing him of the status of the proceeding.

Upon further review of the Company’s customer records, Mr. Bassler is not a customer of UGI PNG. Rather, Mr. Bassler is a customer of UGI Utilities, Inc. – Gas Division (“UGI Gas”). Counsel for UGI PNG informed the Secretary’s Bureau of the mistake, and the Bureau requested that the Company submit a letter indicating that Mr. Bassler is not a UGI PNG customer and request that the formal complaint docket be closed, pending the Secretary Bureau’s investigation as to whether Mr. Bassler’s complaint is against any UGI PNG affiliate or the supplier named in the complaint.

As there is no UGI Gas entity involved in the above-captioned base rate proceeding, UGI PNG respectfully requests that the formal complaint of Mr. Robert L. Bassler, Jr. be removed from the rate case docket, Docket No. R-2016-2580030, and that the formal complaint docket be closed, pending further investigation by the Secretary’s Bureau.


