Response to Data Request

1. For Docket A-110055, will Con-Ed have any customers remaining after the transfer? Does Con-Ed intend to file for an abandonment of its EGS license?

Response:

ConEd is in the process of transferring all of its customers over to Constellation NewEnergy. This is occurring in phases (C&I customers will be the only remaining customers after June) and it is planned to have all customers transferred by the end of 2017. ConEd will file to abandon its license once all customers are transitioned over.

2. For Docket A-2016-2547424, will Constellation Energy Power Choice (Power Choice) have any customers remaining after the transfer? Does Power Choice intend to file for an abandonment of its EGS license?

Response:

Likewise, CEPC is moving towards transfer of all customers, but is doing so in phases-- some customers in Fall 2016, more in June 2017 and the rest November 2017. Eventually all customers under Power Choice will be under CNE and then Power Choice will file to abandon the EGS license.

3. For Docket A-110036, Constellation NewEnergy, Inc. (NewEnergy), please have both Con-Ed and Power Choice submit the amount of Gross Receipts that it is transferring to NewEnergy. Please provide the last 8 quarters of GR, separated by EGS and Quarters. Also, please provide the specific date these customers will be transferred.

Response:

This information will be submitted in a separate, confidential filing.

4. When Constellation had submitted the structure change at Docket A-110168, it was instructed that it would have to file a new application. This was completed, at Docket A-2016-2547424. However, Constellation never abandoned its old license, at Docket A-110168. Please prepare and submit a request to abandon the license at Docket A-110168.

Response:

The petition to cancel/abandon the license at License Docket A-110168 was filed on June 14, 2017 and is pending in Docket No. A-2017-2610738; Data Requests were served and responses were filed on August 3, 2017.

5. For Docket A-110110, is Constellation Energy Services, Inc. planning any transfers at this time, or any other changes to its license?

Response:

Yes, CES will be merging into CNE effective 9/1/17. After all the customers have been moved, we will abandon the CES license.
