Dear Judge Long:

On behalf of the Retail Energy Supply Association (“RESA”) enclosed please find the CORRECTED Rebuttal Testimony of Richard J. Hudson, Jr., St. No. 1-R with regard to the above-referenced matters. In addition to correcting the date of the testimony as well as some originally misspelled words in the version served March 22, 2018, this corrected version:

- Replaces the “below-100 kW” language with “above-100 kW” on page 6 consistent with RESA’s position as set forth in direct testimony; and,
- Due to an oversight, on pages 29-30, an incorrect value for the EGS price in the smart meter thermostat savings example was utilized. The original rebuttal testimony included a value of 7.89 cents per kWh. However, the actual EGS offer that this hypothetical example was based upon is 7.79 cents per kWh. The savings calculation chart has been updated to reflect the correct value.

Enclosed herein are red-lined versions of the corrected pages as well as a complete copy of the rebuttal testimony as revised. There are no changes to the originally submitted RESA Exhibits RJH-12, RJH-13 and RJH-13 and, therefore due to their size, they are not being reserved here. 
