Dear Secretary Chiavetta:

The Industrial Energy Consumers of Pennsylvania ("IECPA")¹ submits this Letter to the Pennsylvania Public Utility Commission ("PUC" or "Commission") in support of the well-reasoned implementation of Supplier Consolidated Billing in Pennsylvania. IECPA believes that Supplier Consolidated Billing presents a potential option for customers that, together with Utility Consolidated Billing and Dual Billing, could further promote customer convenience and customer benefits of retail competition. To that end, and in the event that the Commission ultimately approves Supplier Consolidated Billing as an additional billing option, IECPA recommends that the ability to elect this option (as well as Utility Consolidated Billing or Dual Billing) should remain with the customer at all times.
