**COMMISSION ON ECONOMIC OPPORTUNITY'S
PRE-HEARING CONFERENCE MEMORANDUM**

I. HISTORY

The Commission on Economic Opportunity (CEO) intervened in this matter by Petition to Intervene filed on September 26, 2018. CEO is a not-for-profit corporation and is an advocate for its clients – the low-income population of Luzerne County. CEO serves clients in the UGI Electric territory and has intervened in prior matters before the Pennsylvania Public Utility Commission regarding both UGI Electric and UGI Gas divisions. In those prior proceedings CEO addressed the companies' low-income programs. CEO also was a part of the Commission's development of Act 129 Phase III requirements and similarly addressed the low-income components of Act 129. CEO's interest in the present matter is to address the Company's proposed plan and how it addresses its low-income customers.

II. ISSUE TO BE PRESENTED BY CEO

1. What effect if any will the Company's proposal have on its low-income customers.
2. Does the Company's proposal provide benefits to its low-income customers?
3. Such other additional issues as may arise during the discovery process.

III. WITNESSES

CEO will present the testimony of Eugene M. Brady, Executive Director of CEO, to address the issues above-described.


IV. PROPOSED SCHEDULE


